

WAIVER OF RESPONSIBILITY - elooa CAMPS

RELEASE OF LIABILITY, VOLUNTARY ASSUMPTION OF THE RISK AND WAIVER OF CLAIM AGREEMENT

This **RELEASE OF LIABILITY, VOLUNTARY ASSUMPTION OF THE RISK AND WAIVER OF CLAIM AGREEMENT** ("Agreement"), is entered into by and between

and elooa CAMPS of Authentips GmbH. As used in this Agreement, the term Participant shall include the parent or legal guardian where the Participant is under the age of eighteen (18).

WHEREAS, Participant has voluntarily agreed to enter in elooa CAMP _____
from _____ until _____ in _____;

WHEREAS, Participant, recognizing that participation in the event is a **HAZARDOUS ACTIVITY which is inherently dangerous**, has voluntarily entered the event **despite all known and unknown risk of serious personal injury and/or death presented** by participation in the event elooa CAMP; and

WHEREAS, Participant understands that this Agreement is a general release barring Participant from bringing any claim for personal injury and/or death which is in any way related to participation in the event elooa CAMP; and

WHEREAS, Participant knows his/her own capabilities and limitations regarding each of the events entered; and

NOW, THEREFORE, in consideration of being permitted to participate in the event, Participant expressly and freely agrees as follows:

1. **To ASSUME ALL RISK** of serious personal injury and/or death arising from participating in the event.
2. To inspect the park prior to practicing for or participating in the event.
3. To **WAIVE** any and all claims that Participant may in the future have against Authentips GmbH, their officers, agents, employees, directors, affiliated entities, subsidiaries and all insurers, for any and all loss, damage, injury or expense that Participant may suffer, or that Participant's next of kind may suffer, as a result of Participant's participation in the event, **due to any cause whatsoever, including but not limited to negligence** on the part of Authentips GmbH, their officers, agents, employees, directors, affiliated entities, sponsors, subsidiaries, and entity or person hired to perform any function with respect to the elooa CAMP, and all volunteers.
4. To **RELEASE FROM LIABILITY AND HOLD HARMLESS** Authentips GmbH, their officers, agents, employees, directors, affiliated entities, sponsors, subsidiaries and insurers, from any and all loss, damage, injury or expense that Participant may suffer, or that Participant's next of kind may suffer, as a result of Participant's participating in the event, **due to any cause whatsoever, including but not limited to negligence** on the part of Authentips GmbH, their officers, agents, employees, directors, affiliated entities, sponsors, subsidiaries, any entity or person hired to perform any function with respect to the elooa CAMP, and all volunteers.
5. That this Agreement shall be interpreted in accordance with the German laws.
6. That any dispute regarding the enforceability of this Agreement shall be filed in the courts of Germany, and shall not be transferred to any other Country.
7. I hereby freely agree to allow the elooa CAMP and its sponsors the right to use, in perpetuity, any and all images of me taken during my participation in any and all future elooa event collateral and promotional materials.
